HEALTH OFFICER'S REPORT: Ms. Avallone informed the Board there have been quite a few people identified as being exposed to Measles, mostly on international flights. If proof of immunity cannot be provided, the Health Department must monitor them for 21 days.

Federal Funding Cuts—The Westfield Regional Health Department lost approximately \$230,000.00 worth of federal funding, but none of the core programs under the contract were affected. Some cuts include the Long-Term Care Liaison, and the Vulnerable Populations Coordinator.

The Board discussed planning accordingly for next year's budget due to the loss of funding.

Ms. Avallone advised the Board we are still without a TB/STD contract, but the cases are still being worked on.

All Boards of Health Meeting Recap—Ms. Gagnon and President Rathyen attended the meeting and found it to be beneficial, meeting other Board Members and discussing the commonalities.

ANIMAL CONTROL REPORT—The January through April 2025 reports from Animal Control Solutions were provided to the Board.

Ms. Avallone gave an update on the pit bulls running at large.

Mayor Fagan advised the Board that the Council is working on creating a local ordinance that will deal with this issue.


OLD BUSINESS—None.
