October 2021 Blotter

10/02/2021—At 0834 hours a report was taken for a stolen motor vehicle from a River Road business. The victim stated the incident occurred on 10/01/2021 at approximately 1900 hours—the vehicle was secured at the time of the theft. Taken was a 2020 gray Volvo XC90, valued at \$50,900.

10/04/2021—At 0819 hours a report was taken for an unlawful entry to a motor vehicle parked in the driveway to a Springfield Avenue residence. The victim stated a neighbor witnessed a black male enter and exit the vehicle between 0750 hours and 0800 hours on 10/04/2021. The vehicle, a white 2019 Audi A6 had been unlocked when the suspect was able to gain entry. At the time of the report nothing was taken.

10/04/2021—At 0825 hours a report was taken for an attempted burglary or theft of a motor vehicle parked on Springfield Avenue. The incident occurred just prior to contacting the police, when the victim witnessed a black male wearing a ski mask attempt to gain entry to the vehicle. The vehicle, a black 2020 BMW X7 had been locked when the suspects attempted to gain entry, the suspects were seen vacating the area towards Rt. 24.
