12/03/2021—At 0845 hours a report was taken for an unlawful entry to a vehicle parked at a Rotary Lane residence. The victim discovered their unlocked gray 2019 Infiniti QX60 was entered and rummaged through at some point during evening hours. Nothing was taken from the vehicle.

12/03/2021—At 1948 hours a report was taken for a shoplifting in progress. The caller reported that the suspect left the store without purchasing merchandise and fled the area. The suspect was described as a Hispanic male with curly hair wearing a blue hoodie, jeans, and white sneakers. Taken were four packs of Flonase valued at \$320.
