Weekly blotter December 4 to December 17

12/07/2023—At 2112 hours police were dispatched to an Ox Bow Lane residence for a residential burglary alarm. Upon arrival it was determined there was forced entry into the unoccupied home. While clearing the house, it was evident that a few rooms were entered and rummaged through. Taken was an undisclosed amount of jewelry.

12/08/2023—At 0802 hours police were dispatched to a Ridgedale Avenue residence for a report of an attempted theft from a motor vehicle. The victim stated that at 0453 hours on 12/8/23 a security camera captured three male suspects that walked up the driveway of the residence and pulled the door handles of two parked vehicles. Both vehicles were locked and the suspects were unsuccessful in their attempts; they fled the area in a dark colored SUV.

12/08/2023—At 2030 hours a report was taken for a theft that occurred at a Maple Street business. The victim stated that their Apple Air Pod Pros were taken from a bag that was left unattended between 1400 hours and 1730 hours on 12/7/23. The total amount of the theft was \$250.

12/09/2023—Darwin Cortez-Aguilar, 39, of Summit was arrested and charged with simple assault. Mr. Cortez-Aguilar was processed and transported to Union County Jail with a pending court date.
