Summit Technical Review Committee requested we send you the Fire Truck Circulation Plan for review before submitting out Final site plan application to the City. The Beacon Unitarian Universalist Church is proposing a 2-story building for a new church located at 695 Springfield Avenue. The site has an access drive at the southeast corner of the site off Springfield Avenue with parking and access drive along the north and east sides of the proposed building. The roundabout supports the passenger vehicle circulation for the congregation for drop-offs along the east side, front of the building. There are solar canopies over some of the parking spaces (shaded in gray). There is an existing fire hydrant along north side of Springfield Avenue along the site frontage.
